Executive's Remarks

Because of the timing of our Annual Meeting, we always seem to be sharing old news. Each year we gather in December and share this Annual Report. The bulk of this report, while a great bit of history, does not share the news of the year (2015); rather, it shares the news of the year before (2014). These remarks, unlike the rest of the report, will reflect on 2015 and our many accomplishments.

Throughout 2015 all of our efforts, both volunteers and professional staff, has been to one end: Providing a camp experience for every child, family, school and community organization that wishes to join us on the mountain—regardless of their ability to pay our fees. I like to think of what we do as ensuring that we can provide *Camp For All!*

The phrase *Camp For All* feels a little different as we look back on 2015 and look ahead to 2016. It's more than the title of our on-going capital campaign effort—it's a promise. With our Tier-Pricing and Financial Assistance Program, *it's a promise to our families that every child can attend summer camp on the mountain.* With our Family Camp programs and free community events, *it's a promise that regardless of age you can play outdoors with us.* Through our collaborations with Aaron's Acres, the Hershey Medical Center, the National Military Families Assocation, and, in 2016, the Easters Seals, *it's a promise that all kids, regardless of abilities or life experience, have a safe place to be kids.* I am proud to be a part of this promise—the promise of a *Camp For All*. It's something worth celebrating.

We've had a lot to celebrate in 2015. We've raised more than 2 million dollars for our capital campaign effort. We added full-time Camp Conrad Weiser and Outdoor Center Directors. We had more than 1000 people attend our Egg-Stravaganza Egg Hunt. Both our Conrad Weiser and Bynden Wood Day Camp programs grew in summer enrollment. We were recognized as "The Best In Berks" for youth summer camp programs. We received an award for our partnership with our local public library. The list goes on.

Our staff is rightfully proud of their year, and we hope you, as friends and family, share in that sense of accomplishment. We thank you for your support.




